Course Description

The course provides a discussion of a wide range of issues in global public policy. The classes address the rise and development of GPP in various mechanisms such as global regime, market pressure, common issues and actors (state, non-state actors, and international institutions), and how this leads to the creation of a global village with various consequences, both negative and positive. The subjects include the discussion on international institutions, the role of non-government organizations, policy convergence, and the issues of legitimacy, accountability, and participation in global regimes. More importantly, the class provides a case study on several topics, such as global economic policy, global health policy, global energy policy, global environmental policy, and global social policy. Students will have space to raise and discuss the issues with the lecturer and peers through active listening, guest lectures, reviewing journals and articles, and paper development.
